# EQE PAPER C

## 2-DAY GUIDED EXAM COURSE

### Objective

The 2-day course aims at improving the skills of candidates preparing for the C paper of the European Qualifying Examination (EQE). In preparation, the participants will be required to hand in their answers to one C Exam paper. This will be discussed, followed by practising one shortened and one full paper, guided and assisted by the tutor. By the end of the course the participants will have identified their weaknesses and will know the areas that they need to concentrate on in the period left before sitting the EQE enabling them to improve the overall score on the C paper. In this course candidates will learn how to efficiently perform the methodology under time pressure on actual papers and will get a good feeling for how marks are awarded in an actual exam.

### Course Concept

Prior to the course, the participants have to make one C paper at home. This paper will be corrected by the tutor and returned during the course, with detailed marking sheets and comments.

On the first day this paper is discussed by 're-making' the paper in small steps according to the methodology covered by the 3-day C Methodology course. This will demonstrate how the methodology can be applied and will enable candidates to precisely identify where their analysis may have been faulty and where they may have lost marks in their answer. In the afternoon the tutor will discuss another exam paper; this paper is prepared by the candidates before the course.

During the second day, a full paper is made in the same way under increased time pressure. This can be seen as a guided mock exam.

Candidates are expected to participate actively and work under time pressure.

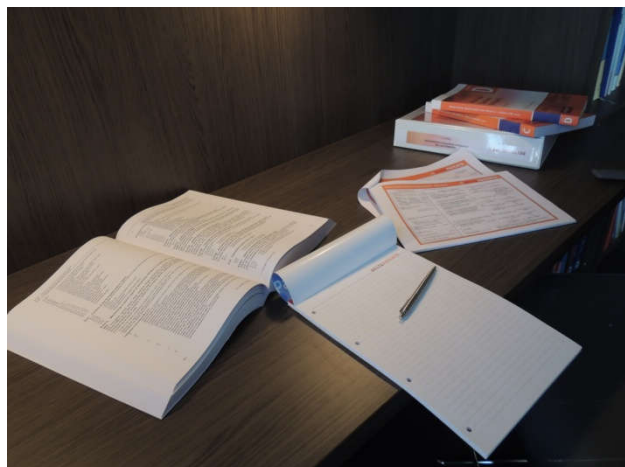
The three C papers that will be practiced and analysis/model solutions for those papers. The model solution also demonstrates the analysis of the paper how the methodology has been applied for the specific paper.

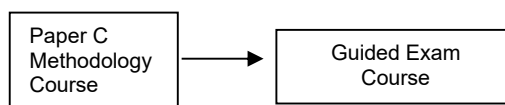


## Who should attend?

The course is aimed at candidates preparing for the European Qualifying Examination. It is suitable for re-sitters as well as first-time sitters. Participants are expected to have reached an advanced stage in their own preparations for the EQE.

## Prior training

## Course language

All materials and tuition will be in English.

## Online and on-site training EQE 2023

The Covid-19/Corona crisis is still across Europe and the whole world, and DeltaPatents is thinking ahead and of candidates preparing for the EQE 2023. For Pre-Exam as well as Main Exam, we will offer online training courses and if the situation permits, also on-site training on a limited scale.

We understand that it will be different, the interaction between tutor and candidates will be different. You are used to our high-level courses and we will do our utmost to continue to offer this service, also through our online training courses.

How does it work:

- For the online training, we use WebEx. With this system you can interact with the tutor and the other candidates, ask questions and give answers to the questions of the tutor.
- Course days will be from 9.00 hrs. to approximately 17.00/17.30 hrs. We will present the topics in blocks of 45 to 60 minutes, followed by a 15 minute break. For lunch we will have a 45 minute break.
- The course materials will be shipped to you beforehand. Additional materials will be available in our online training environment (Eduframe/Canvas).

At this moment, April 2022, we have only scheduled some Methodology courses as online training courses and some on-site. The Guided Exam courses will only be offered as an online course. The on-site courses are subject to Covid-19/Corona crisis developments. The fees for the online course are lower, reflecting the lower costs.

## Attendance limited to 24

A maximum of approximately 24 students can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal assistance during the practicing of the cases and the paper.

## Certificate

A candidate will receive a certificate after attending the course.

## Course fee

The price of the “**Online 2-day Paper C Guided Exam course**” is **€ 1.310** (excluding 21% VAT). This price includes online tutoring, course materials, shipment of the material inside the EU and access to online administration platforms (Eduframe and Canvas). An administrative fee of € 125 is charged for every booking.

If more than one course is booked at the same time, only one administrative fee of € 125 will be charged.

## Shipment outside the EU

If given online, we will ship the course materials to the office address of each candidate (instead of to the course venue). Shipment costs to the EU are included in the course fee. Additional shipment and customs costs for countries outside the EU (e.g. Turkey, Switzerland, Norway and the United Kingdom) will be added to the standard course fee for the online courses. It is advised that candidates from the same company attending the same course, use their office address for shipment of the course materials. All materials can then be shipped at the same time, which keeps the costs low.
