# EQE 2022 – MAIN EXAM

## D-LEGAL

### 8-DAY COURSE

#### Objective

The course aims at augmenting and deepening the knowledge acquired during the Basic (Pre-Exam) Legal Training to a level required for the C & D parts of the EQE Main Exam.

#### Who should attend

Candidates who were successful in the Pre-Exam and are preparing now for the next step, the Main Exam. The knowledge from this training is needed to be successful at the Paper D Main Exam.

#### Course Concept

Legal lectures will be cover legal changes in the EPC & PCT since the Pre-Exam, the more advanced legal subjects such as entitlement, enforcement, and petition for review. The Ancillary Regulations will be covered, as well as a specially selected subset of case law (headnotes of approximately 400 decisions and full text of approximately 60 decisions are provided).

To gain confidence and experience in applying the law, students will have to rehearse the full range of legal subjects guided by a selection of approx. 250 exam-oriented questions. The answers have to be prepared at home and have to be handed in. A selection will be marked individually, and returned with comments and suggestions for improvement. The answers and any unclear subjects will be discussed during the next session.

#### Practice before kickoff

Candidates will be asked to send in their solution to a DI paper before the 2 introduction days. This paper will be corrected by the tutor and discussed during the introductory session.

#### Course schedule

- 8 full day sessions, discussing exam-oriented questions and presenting Paper D Main Exam subjects
- The sessions are held every 2 weeks. This provides ample opportunity for further individual study and for answering the questions

#### Training Material

Material will be provided with a binder with:



- Questions/home-work.
- Main-Exam Questions for Paper D book.
- Sheets explaining the more advanced subjects of the EPC, PC and PCT.
- Additional legal training material
- Selected subset of case law (headnotes)

The copyrighted course material is provided for the personal use of the participants.

## Course Language

All material will be in English. Tuition will also be in English.

## Attendance Limited to 25

A maximum of approximately 25 students can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal feedback.

## Certificate

A candidate will receive a certificate after attending at least 6 out of the 8 sessions and handing in homework at least 6 out of 8 modules.

## Course Dates, Time and Location

The course will start in May and runs until September (with a 6 week break in the period July/August).

Course time: 9.00 – 17.00 hrs.

The course will be given either **online** (WebEx) or at **Aristo Utrecht** (Lunetten), this depends on the Covid-19 situation in 2021.

## Registration and invoicing

The invoice will be send immediately after registration. Please note:

- Up to 2 months before the start of the training course an early-bird-discount will be given.
- From 2 months up to the start of the course, the full price without discount will be charged.

## Registration procedure

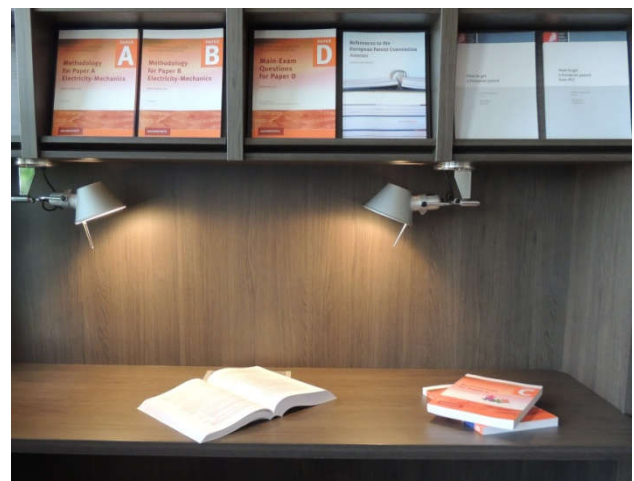
