Objective

The methodology taught in this course aims at bringing candidates who already followed the Dutch Patent Attorney Training Program to the entrance level required for practicing EQE Papers A/B.

Until the EQE 2016 for the A/B part a choice is given between Electricity-Mechanics and Chemistry. Starting at the EQE 2017 a single paper A and a single paper B will be examined, covering both technical fields.

Who should attend

Candidates who were successful in the Pre-Exam and are preparing now for the next step, the Main Exam. Three years of full-time experience in the relevant field of patent creation and prosecution are recommended. For sitting the EQE three years of full-time experience is required.

Course Concept

The training programme for candidates preparing for Paper A and B of the European Qualifying Examination consists of the following:

- This module starts with 3 full days of methodology on paper A (1,5 day) and B (1,5 day), where tactics for handling the papers will be given. The tactics will be practiced using cases with topics that probably will be part of the exam papers.
- Following the methodology session, the students have to prepare two sets of adapted EQE A and two adapted B papers at home and hand in their answers. They also have to prepare two actual exam papers (A and B 2017 and 2018). The answers will be checked and marked by the

tutor. During four half-day sessions the papers will be discussed with the group and feedback on the individual work will be given.

Course schedule

- 1,5 day day session for Paper A, introducing the methodology
- 1,5 day sessions for Paper B, introducing the methodology
- 4 half day sessions, discussing homework/exam papers

Training Material

A comprehensive set of high quality, up-to-date Training Material will be provided with a binder with:



- Approximately 100 overhead sheets introducing and explaining how to tackle the exam papers.



- The papers that will be practiced.
- A model solution and analysis of each paper.

The copyrighted course material is provided for the personal use of the participants.



Course Language

All material will be in English. Tuition will also be in English.

Attendance Limited to 20 - 25

A maximum of approximately 20 – 25 students can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal feedback on their homework.

Certificate

A candidate will receive a certificate after attending at least 5 out of the 6 sessions and handing in homework of all 3 A and 3 B papers.

Course Dates, Time and Location

The introductory sessions will be in October/November, followed by 4 half day discussion-sessions in the period November – February.

Course time: 9.00 – 17.00 hrs. (full day) and 09.00 – 13.00 hrs. (half day).

The course will be given either **online** (WebEx) or at **Aristo Utrecht** (Lunetten), this depends on the Covid-19 situation in 2021.

Registration and invoicing

The invoice will be send immediately after registration. Please note:

- Up to 2 months before the start of the training course an early-bird-discount will be given.
- From 2 months up to the start of the course, the full price without discount will be charged.

Registration procedure

The price for the Main Exam Paper A and B training is € 4.295 (excluding VAT and a registration fee of € 125). Prices include tuition, course materials, refreshments and lunch (at full day sessions).

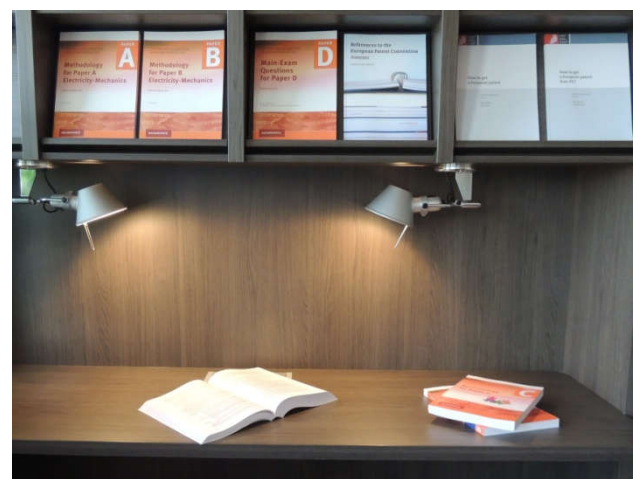


Registration fee
