5-DAY COURSE

Objective

This course is especially for candidates, having acquired sufficient knowledge in the Pre-Examination modules and the D-Legal Main-EQE module. The candidates will be trained on focusing to use the knowledge in an efficient way in order to pass the exam. Particular emphasis is given to the D-II part of the exam (Legal Opinion based on a client's letter).

Who should attend

Candidates who were successful in the Pre-Exam and are preparing now for the next step, the Main Exam. Three years of full-time experience in the relevant field of patent creation and prosecution are recommended. For sitting the EQE three years of full-time experience is required.

Course Concept

During the 2-day methodology training in October we will explain our methodology for EQE Paper DII part of the exam (legal opinion). The tactics will then be practised using 2 DII exam papers. The papers will be practised and discussed step by step in the group and a detailed analysis and model solution for the papers will be presented. In this way, the students will be able to put the theory from the methodology training into practice. By sending in a solution beforehand, they will also see why our methodology works on the exam papers.

The methodology training is followed by practicing papers: the students/candidates will have to hand in a solution of 4 D-papers. These papers will be checked and marked by the tutor and discussed with the group and feedback on the individual work will be given. This will be done in half-day discussion-sessions. These sessions are scheduled from October until February. After having discussed 2 exam papers, the students will follow a guided (mock) exam training, where the tutor will lead them step-by-step through an exam to improve the efficiency. All documents will be read together and students will give their solutions to parts of the exam.

Course schedule

- 2 full day sessions, introducing the methodology
- 4 half day sessions, discussing homework/exam papers
- 1 full day session, guided mock exam

General

- How to prepare for the D paper
- Time management
- Styles and detail of answering

DI-specific

- Reading and analyzing the question
- Sufficient legal basis
- When is something relevant or not relevant

DII-specific

- Analyzing the client's letter
- Organizing the information using tools such as a timeline & invention matrix
- Dealing with recurring problems such as publication dates, invalid priorities, "first application", insufficiency of disclosure
- Advising the client and improving his position
- Recognizing threats from the competitor

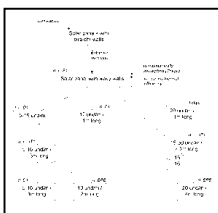

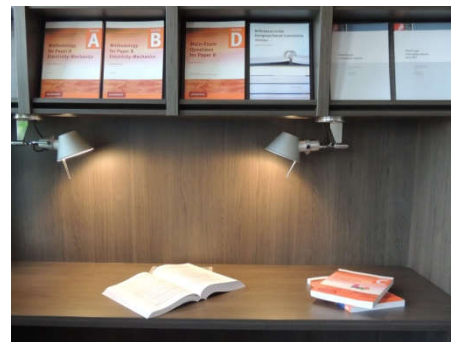

Course Language

All material will be in English. Tuition will also be in English.

Attendance Limited to 20 - 25

A maximum of approximately 20 - 25 students can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal assistance during the practicing of the cases and the paper, and provide personal feedback on their homework.

Certificate

A candidate will receive a certificate after attending at least 6 out of the 7 sessions and handing in homework of all 4 D papers.

Course Dates, Time and Location

The introductory sessions will be in September/October, followed by 4 half-day discussion-sessions and the guided mock exam session in the period October – February.

The discussion sessions of the D and C exam papers will be combined on one day.

Course time: 9.00 – 17.00 hrs. (full day) and 9.00 – 12.45 hrs. (half day).

The course will be given either **online** (WebEx) or at **Aristo Utrecht** (Lunetten), this depends on the Covid-19 situation in 2021.

- Up to 2 months before the start of the training course an early-bird-discount will be given.
- From 2 months up to the start of the course, the full price without discount will be charged.

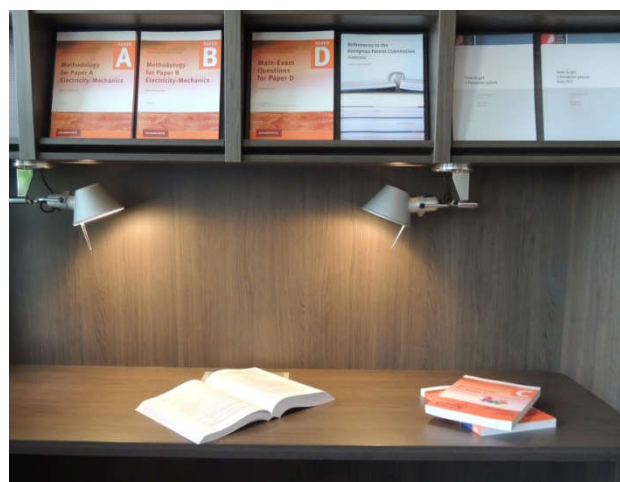
