EQE Pre-Exam training

For the Pre-Exam, we offer:

- Pre-Exam Distance Learning
 The same as the Pre-Exam Integrated course, but as distance learning: with homework schedules and 2-/3
 - week video sessions.
 - Pre-Exam Integrated course
 This intensive 12-day course (in 4 blocks) will bring candidates from a basic level with no or limited legal knowledge to the level required for the EQE Pre-Exam. All legal topics, EPC procedural, EPC substantive and PCT, are covered. Legal interactive tutorials will be alternated with practicing what has been learned: candidates will experience from the start how this knowledge can be used in an efficient way in order to pass the Pre-Exam.

 Homework is an integral part of the course. The questions test absorption and understanding. We provide full answers for all homework questions for self-evaluation.
- On the first day of course, we explain how to answer the legal questions for the Pre-Exam. We will teach a methodology, which will help to score optimally on the legal part of the Pre-Exam and how to deal with the True/False format

 On the second and third day of the course, we cover the Claim Analysis part of the Pre-Exam with a specific exam methodology. The methodology is practiced using multiple choice questions and cases and one full preexam.

3-day Legal and Claim Analysis Methodology Course

EQE Main Exam training

Our modular approach allows candidates to freely choose which paper(s) they wish to prepare for in a certain exam year. We offer:

Paper D Distance Learning

This is a **brand new** 10-day course for candidates preparing for Main Exam Paper D. This course not only includes our DI and DII Methodology (1 day DI Methodology and 2 days DII Methodology), but also gives candidates the opportunity to gear up their legal level by augmenting and deepening the knowledge acquired during the Pre-Exam Legal training to a level EQE Main Exam. To achieve this, we use the Main Exam Paper D Questions and Answers book as homework and present more advanced legal subjects

Methodology courses for each paper

In these 2 or 3 day courses, we detail the requirements of the paper and clarify the key issues of the paper. We give a step-by-step approach for efficiently handling the paper, including practical analysis techniques, checklists and guidance in optimising scoring of marks with the knowledge you have. The methodology is developed and tested over more than a decade. In the courses, we show how the methodology works by applying it to at least one exam paper.

Our methodology courses for re-sitters apply the methodology to the last exam paper.

(Guided) Exam courses for paper C and D

We offer a variety of courses for guided practicing of papers, depending on demand. For example:

- 2-day course wherein a handed-in paper is corrected and marked and discussed during the course. One more exam paper is practiced during the course, with guidance and assistance from the tutor.
- 4- or 5-day Paper D Guided Trial Run course providing a final test of EQE readiness, combining guidance through up-to-date DI and DII exam questions with practice under time pressure. The 5-day course includes 1-day Crash Methodology DI and DII.



1-day course to practice exam papers a few weeks before the real exam in order to adjust your method, on papers as close as possible to the final exam.

Candidates will practice in real-time conditions on the following papers:

- 2 different mock exams for the preliminary exam
- 2 different mock exams for paper D
- 2 different mock exams for paper C
- 1 mock exam for paper A
- 1 mock exam for paper B

Each one of these mock exams is set-up exactly as the final exam, except for the Wiseflow environment which is not used. The structure and timing of each paper is the same as for the final exam, so that candidates can practice in almost real conditions. At the end of each mock exam, the tutor will provide his answers in a group session, and answer any question candidates may have about the paper.

Documents will be sent electronically just before the mock exam, with printable parts indicated. At the end of each exam, candidates will send back their answer by email (WORD format, or Google form for the pre-exam).

After a few days, the tutor will send back the papers with a grade, as well as individualized comments (except for pre-exam where an auto-correction is possible).

Course fees EQE 2023

Here below you find an overview of the course fees for the EQE 2023 courses. This year we will schedule on-site as well as online courses (depending on the Covid-19 situation).

The course fee contains tutoring, course materials, use of online training programs (Eduframe and Canvas), and, if given on-site, catering. If given online, we will ship the course materials to the office address of each candidate. Shipment costs to the EU are included in the course fee. Additional shipment and customs costs for countries outside the EU (e.g. Turkiye, Switzerland, Norway and the United Kingdom) will be added to the standard course fee for the online courses. It is advised that candidates from the same company attending the same course, use their office address for shipment of the course materials. All materials can then be shipped at the same time, which keeps the costs low.

A registration fee of \in 125 is charged to each invoice. If candidates from the same office register at the same time, the registration fee will be charged only once.



Integrated EQE training programs

Our modular system allows candidates to choose a program which matches their learning style and needs in prioritising study versus balancing it with focussing on work or private life. Here two exemplary programs are shown, a fast track program and a slow-track program. Please contact us to discuss how to optimise your preparation depending on your needs.

Fast track program

In this program, which is the default program in the Netherlands, candidates aim to pass the Pre-Exam, immediately followed by next year passing all four Main Exam papers.




The Main Exam year will be challenging: four papers in parallel, including paper DI which requires a lot of hours of studying. To spread the load, a good legal preparation is already required in the Pre-Exam year. For this our Legal Cram Course is ideal. The Pre-Exam training is then finished by the Pre-Exam Claim Analysis course.

The Main Exam training can start with our Legal Refresher Course, followed by the training for the four papers in parallel. The paper training ideally starts with a Methodology Course, followed by a Guided Exam Training and, optionally, finished with our Correction Paper program.

Slow track program

In this program, candidates plan a couple of years for passing the Main Exam. Here a schedule is shown wherein Paper D is taken in the first Main Exam and in the following year papers A, B and C are taken. In the schedule shown here the legal knowledge build-up is slower.
