- ADA/AAD2019 will be **superseded by ADA/AAD2022 per 10 September 2022** OJ Suppl 3/2022 (published on 10 Aug 2022):
  - Main changes are new provisions:
    - To implement a process of direct clearing of debit orders;
    - To introduce a safety net for replenishments of deposit accounts;
    - To reflect the full deployment of Central Fee Payment (and the abolishment of Online Fee Payment; OJ 2022, A81: "Notice from the EPO dd 19 July 2022 concerning Central Fee Payment") and the changes this will entail for managing automatic debit orders.
  - The need to make these amendments has also been taken as an opportunity to rearrange and split up a number of existing ADA provisions to improve readability, without, however, substantially changing their content.
    - The ADA provisions have been split, rearranged and renumbered extensively an indicative concordance table is given below.

  indication of an e-mail address in Box II (for the applicant) or IV (for the agent or common representative) would
  have authorized the receiving Office, the ISA and the IB, if they provide such a service, to send notifications
  exclusively by e-mail to that address.
- o See also PCT AG-IP Annex B: IB allows communications to be sent by e-mail
- The basis for notification per email seems to be Rule 4.4(c) "In order to allow rapid communication with the
  applicant, it is recommended to indicate any teleprinter address, telephone and facsimile machine numbers, or
  corresponding data for other like means of communication, of the applicant or, where applicable, the agent or the
  common representative."

If the request is received on a day on which the EPO is not open for the receipt of documents, the decisive payment date will be the next day it is open for this.

# Information on the schedule for the EQE 2023 examination papers

#### General

The EQE 2023 exam schedule is now available. Candidates are advised that this document may be subject to minor changes as testing continues.

The EQE 2023 will take place online using the same setup as the EQE of 2021 and 2022. On examination days, candidates are advised to log on to the online examination system's internet platform at least 20 minutes before the start of the relevant paper. Information on how to register and log on to the online examination system will be communicated in due course.

The pre-examination and both papers C and D will be split into parts. This means that candidates will not be free to allocate their time as they see fit across the different parts of the papers. To compensate for this restriction, the total duration of the relevant papers has been extended. Once the time allowed for a part has elapsed, it will not be possible to go back to that part.

# Pre-examination - 17 March 2023

The pre-examination will have the same syllabus and character as before, but it will be split into four parts. Each part must be completed before the start of the next break, with the next set of questions only becoming available after the break. The pre-examination lasts four hours and forty minutes.

Candidates will be allowed to print the description of the invention as well as the prior-art documents for the claim analysis parts before the start of the appropriate part. The documents allowed for printing will be made available during the break preceding the relevant claim analysis part.
