# EQE PAPER D

## 3-DAY METHODOLOGY COURSE

### Objective

The D paper is generally considered the most challenging of all EQE papers. All EPC and PCT subjects may be tested, but you will not be equally strong on all subjects. You need to understand your strengths and weaknesses, and to prepare accordingly. A good pass is possible by scoring 75% of the available points for 75% of the legal issues. By the end of this course, you will understand how to score high points on D for the things that you know well and the things you can do well. You will understand what must be handed-in to get points, and you will have practiced a proven approach for generating answers. We will discuss alternative answers and different styles that can also score points. You will also be given many rules-of-thumb to guide this approach, based on our many years of EQE experience. We will also provide practical tips about how to organize your reference materials, how to study, what to take to the exam and how to divide your time between DI and DII parts.

### Objective for DI

By the end of this course, you will be able to optimize the points you can score with your level of legal knowledge. Crucial to success in the D paper is sufficient in-depth legal knowledge. You will practice finding things quickly in your material, and applying your legal knowledge to the facts given to get a good

answer. You will compare your answers with our examples, and with the answers of other participants, to better understand the legal arguments required for each question, and the legal basis that is necessary and sufficient for points.

### Objective for DII

Even a very high degree of competence in DI is not enough to score high points on DII. With an usual score of 20 out of 60 points for DII, this is the most difficult part and often the reason for failing. By the end of this course, you will have practiced a step-by-step approach that has been proven to work on all recent papers, without hindsight of the answer and without knowledge of the official examiners' report. You will practice combining your legal knowledge, and practical experience, with this approach to produce a high-scoring DII answer.





## Course Concept

Competing courses often concentrate on explaining and defending the EQE Compendium answer – this can help the legal understanding, but it does not give the tools to produce a comparable answer yourself. Our approach addresses the problem you will face on next year's exam – starting from a DI or DII question, how do you produce a good answer in the time available?

DeltaPatents' new DI and DII methodologies have been developed and tested using the comments and experiences of many former candidates.

One day is spent on DI, where the theory and practice of tackling DI are taught using past DI questions. Each participant attempts the questions, followed by a detailed analysis by the tutor and group discussions. In particular, the answers are dissected to see why some comments are included, and why others are not.

The DII methodology is taught using cases derived from past papers during the remaining two days. The cases represent frequently-recurring aspects, and illustrate the tools available to extract and organize the information, to recognize what is important and to incorporate point-scoring comments in the final answer. The skills are then applied step-by-step to a recent DII paper, with regular group discussions to explore different opinions and approaches. Examples, worksheets and flowcharts are provided, so that the steps are clear and consistent.

## Course for Re-Sitters

If you are a re-sitter, we advise you to attend the Paper D Guided Trial Run course. Our methodology will be presented briefly and furthermore you practice DI and DII, guided by the tutor. The most recent D paper will be part of the course materials.

## Prior training

The candidate is expected to be at a legal knowledge level of EPC and PCT beyond that required for the Pre-Exam. We offer suitable Q&A books with extensive sets of questions and fully detailed answer:

- **Basic Legal Questions for Pre-Exam and Paper D), “L-book”:** Study Guide, topical Q&A at Pre-Exam and Paper D level
- **Main-Exam Questions for Paper D, “D-book”:** Study Guide, Q&A of proprietary and earlier EQE DI-style questions

## Subsequent training and practice

This course teaches a basic methodology. To use it efficiently on the EQE, you need to practice it, and where necessary, adapt it to your knowledge, style and reference materials. We recommend further practice on at least 3 D papers (DI and DII parts).

We offer suitable DI and DII practice during our:

- **2-Day Paper DI and DII Guided Exam** (*strict condition: you must have followed the 3-day Methodology course*)
- **4- or 5-Day Paper D Guided Trial Run for Re-sitters** (the 5-day includes 1-day Paper D Methodology crash course)
- **1-day Paper D Mock Exam** (practice a D paper under real exam conditions, using WISEflow)

All of our D training and model solutions are based upon this methodology. It is therefore highly recommended to follow the DI and DII Methodology course before doing the other training.

## Course language

The course will be offered in English in the Netherlands, Denmark, Italy, Sweden, Germany and the U.K.

In Germany, courses will be offered in German.

## Online and on-site training EQE 2024

For Pre-Exam as well as Main Exam, we will offer online training courses and if the situation permits, also on-site training.

We understand that it will be different, the interaction between tutor and candidates will be different. You are used to our high-level courses and we will do our utmost to continue to offer this service, also through our online training courses.

How does it work:

- For the online training, we use WebEx. With this system you can interact with the tutor and the other candidates, ask questions and give answers to the questions of the tutor..
- Course days will be from 9.00 hrs. to approximately 17.00/17.30 hrs. We will present the topics in blocks of 45 to 60 minutes, followed by a 15 minute break. For lunch we will have a 45 minute break.
- The course materials will be shipped to you beforehand. Additional materials will be available in our online training environment (Eduframe/Canvas).



At this moment, March 2023, we have only scheduled some Methodology courses as online training courses and some on-site. The Guided Exam courses will only be offered as an online course. The on-site courses are subject to Covid-19/Corona crisis developments. The fees for the online course are lower, reflecting the lower costs.

### Attendance limited to 24

A maximum of approximately 24 participants can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal assistance during the practicing of the cases and the paper.

### Certificate

All participants will receive a certificate after attending the course.

### Course fee 3-day D Methodology

The prices are as follows:

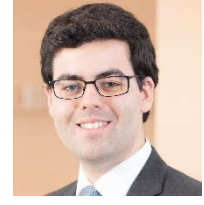

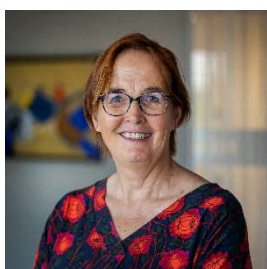
