## EQE PAPER C 2- OR 3-DAY REFRESHER COURSE FOR RE-SITTERS

### **Objective**

This 2- or 3-day refresher course meant for candidates who already followed our methodology course in precious years and need to re-sit the C exam. It could also be useful as an extra practice for first time sitters.

### **Course Concept**

The course aims to let candidates practice for the C exam in a very time efficient way.

Day 1 and day 2: A short summary of our methodology will be presented. Older C exams (of 2013 or earlier) have been turned into cases of approx. 1/3<sup>th</sup> of the original size. Most of the 'standard' issues have been removed like having to make a time line, performing a few normal novelty attacks or problem-solution attacks. The special issues have been kept.

Some cases are a bit longer and still includes some of the standard issues.

Candidates have to prepare some of the cases at home. Solving a case is expected to take approx. 1 hour per case. Writing it down could take a further hour. During the online session, each case will be discussed in sequence. Having discussed a case, the candidates get a marking sheet for the case and some time to mark their own solution.

A detailed model solution is provided for each case. **Day 3**: Candidates will practice the C 2023 exam paper, guided by the tutor. The tutor will go through the paper, step-by-step, using the DeltaPatents methodology.

During this course, candidates will use the WISEflow system (this is the system the EPO uses for the e-EQE).

### **Training Material**

- A set of cases, model solutions and marking sheet.
- The copyrighted course material is provided for the personal use of the participants, who are asked not to make reproductions without permission.
- Use of WISEflow, the exam system used by the EPO).

### Who should attend?

The course is aimed at candidates preparing for the European Qualifying Examination 2024. It is an extra practice for first time sitters and a refresh course for resitters.





The course will be given in English and German.

### **Online training EQE 2024**

The course is offered online. The course will be from 9.00 hrs. to approximately 17.00 hrs. There will be regular breaks and a lunch break of 45 minutes. The course materials (cases) will be shipped on beforehand or made available in our online training environment (Eduframe/Canvas/WISEflow).

### **Attendance limited to 24**

A maximum of approximately 24 students can take part in the course. This limitation will give the tutor the opportunity to discuss unclear issues in more detail and provide personal assistance during the practicing of the cases and the paper.

### **Certificate**

A candidate will receive a certificate after attending the course.

### **Course fee**




