MOCK EXAMS

Objective

Practice a few weeks before the real exam in order to adjust your method, on papers as close as possible to the final exam.

Get an evaluation on your level for each paper, thanks to a personalized marking of each paper, comments and advices from the tutor, in particular on the methodology used and the structure of your answer.

Based on the outcome, make final adjustments to your methodology before the exam.



Course concept

This course is based on mock exams made-up by our tutor Grégory BAQUE, who has been a DeltaPatents tutor to the French-speaking candidates for 10 years. These mock exams focus on recent changes in the exam itself, in the law, and on recurring aspects of the EQE, which could be part of the final exam.

Candidates will practice in real-time conditions on the following papers :

- 2 different mock exams for paper F
- 1 mock exam for paper M1
- 2 different mock exams for paper M2 (the same as D1)
- 2 different mock exams for paper D
- 2 different mock exams for paper C
- 1 mock exam for paper A
- 1 mock exam for paper B

Each one of these mock exams is set-up exactly as the final exam. The structure and timing of each paper is

the same as for the final exam, so that candidates can practice in almost real conditions.

At the end of each mock exam, the tutor will provide his answers in a group session, and answer any question candidates may have about the paper.

Documents are provided electronically, with some printable parts. At the end of each exam, candidates will send back their answer electronically.

After a few days, the tutor will send back the papers with a grade, as well as individualized comments (except for paper F and part of paper M1 where an auto-correction is possible).

Training Materials

Candidates will receive the papers (printable and nonprintable parts), as well as a model solution after each mock exam.

Who should attend ?

These mock exams are aimed at candidates preparing for the European Qualifying Examination. It is suitable for both first-time sitters as well as for re-sitters. They require a very good knowledge of the EPC and the legal framework around European patents (candidates should be almost ready to take the exam). It is preferred, but not mandatory, that candidates have followed the various methodology courses provided by DeltaPatents.
